## **What To Do When...**

## **Your Wireless Connection Drops**

Whether you're on the road or at home, a wireless connection can drop unexpectedly and for no readily apparent reason. Many people

depend on wireless networks to work and stay connected with friends and family, so a dropped connection can create serious problems. Consider the following troubleshooting tips as you try to reconnect to your network or the World Wide Web.

#### **Inspect Your Connections**

If you've already established a wireless network at home, start by turning your router off by unplugging it and pressing the reset button located on the back. Be sure to reset your cable or DSL modem, as well. To do this, simply leave the power cord unplugged for a minute and then reinsert the cord. If you use a laptop with built-in wireless capabilities, try rebooting and reconnecting to the network. A troublesome Wi-Fi adapter could also be the problem; disconnect and then plug in an external adapter. Next, check to see if your wireless router cords are plugged in. Your router should be connected to a power supply and have connections to your cable or DSL modem. Don't overlook these basic tips, as they can save you frustration further down the line.

#### **Reposition The Computer**

Distance affects the quality of your wireless signal, which can result in periodically dropped connections. Place your wireless router or access point in a centralized location within your wireless network. If your wireless connection seems weak or intermittent, try moving it to various spots around your home. Open your wireless settings to check if your signal has strengthened. This is one way to ensure that you've chosen an ideal spot for an access point.

A network provides the clearest signal in a wide, open space, but homes typically don't come without walls, doors, metal, and floors. Wireless signals are weakened as they pass through aluminum and heavy wood or bounce off reflective surfaces such as windows and mirrors. In an ideal environment, 802.11g routers have a range that can extend up to 300 feet, but the obstructions in your home decrease this range significantly. Keep these points in mind when you arrange your network. You can also reposition your router's an-

tenna to improve the wireless signal. Similarly, it's best to keep your note-book as close as you can to the router to avoid obstacles. If you're still experiencing problems, try extending your network's range by adding a repeater or long-range antenna to your router.

#### **Combat Network Interference**

Network interference is a common culprit of diminished wireless signals. For instance, an appliance such as a microwave can interfere with wireless signals. Cordless phones have skyrocketed in popularity and can block a signal, as well. Any devices that operate on the same 2.4GHz frequency as your wireless network will likely weaken the network's signal strength. To avoid these wireless barriers, place your access point at least 3 to 6 feet away from home appliances that could interfere.

#### **Switch Channels**

Another common cause of network interference is other wireless networks. It's possible that neighbors using Wi-Fi or other nearby networks are obstructing your signal just as much as any wireless device. If other access points or routers in your area are using the same wireless channel as your network, your signal strength could fade.

Fortunately, Wi-Fi equipment (in the United States) supports up to 11 channels. This range of frequencies is not unlike different radio stations. The solution is to change your wireless router's default channel and then check your wireless settings to see if the signal has increased.

To change the channels on your wireless router, begin by opening your Web browser. Next, type the IP

(Internet Protocol) address of your router in vour Internet browser's Address bar. (The IP address is often 192.168.1.1, but check your router's users manual to be sure.) Click the Wireless option on the Web page. For instance, in our D-Link router, we clicked the Wireless button in the left-hand menu and then selected the Home tab to access the wireless settings. If an Auto Select box is checked, uncheck it and switch to a new channel by selecting a number from the drop-down menu. Continue to test different channels until you find a frequency that works.

#### **Check Your Wireless Adapter**

If you're a frequent traveler who relies on Wi-Fi hotspots, wireless network adapters are indispensible. An adapter communicates with the router. If you're having difficulties connecting to a hotspot, your adapter may not be working properly. To remedy this problem, you'll need to either reinsert the wireless adapter into the PC card slot in your notebook or replace the adapter altogether. In order to improve the communication between your router and laptop, consider using a USB network adapter, which adds the option of a hi-gain antenna and ultimately enhances your signal range.

Once you've ensured that your adapter is correctly connected, you should determine if Windows has recognized the adapter and if it is working normally. To do this in WinXP, click the Start menu, Control Panel, Performance And Maintenance, and System. In the System Properties window, select the Hardware tab and click the Device Manager button. Click to expand Net-

work Adapters in the Device Manager and see if the name of your wireless adapter is there. Right-click the wireless adapter and select Properties—the Properties window will inform you whether the adapter is working. Another troubleshooting option is to select the Driver tab and update your driver.

Vista users should click Start, Control Panel, Hardware And Sound, and Device Manager. From this point on, follow the steps outlined for WinXP in order to check the status of the wireless adapter.

With a little tweaking and troubleshooting, you should be able to reconnect to your wireless network.

Do you really know how to forward an e-mail? It is estimated that over fifty percent of email users do not know how to do it properly. Do you wonder why you get viruses or junk mail?

Email messages get forwarded countless times without concern for the security of the previous sender's addresses. Every time you forward an e-mail there is information left

over from the people who got the message before you, namely their e-mail addresses and names. As the messages get forwarded along the list of addresses builds and builds creating a huge resource for spammers. All it takes is for someone to get a virus and the infected computer can send that virus to every e-mail address that has come across that computer. Even if the address collection doesn't result in a virus it surely will be harvested by spammers or someone looking to make a couple of cents for a listing of good email addresses. How do you stop or at least minimize the propagation of email addresses?

There are several easy steps that we should all practice.

(1) Before you send out a forwarded e-mail, DELETE all of

the other addresses that appear in the body of the message (at the top). That's right, DELETE them. Highlight them and delete them, backspace them, cut them, whatever it is you know

how to do. It only takes a second You MUST click the 'Forward' button first and then you will have full editing capabilities against the body and headers of the message. If you don't click on 'Forward' first, you won't be able to edit the message at all.

(2)Whenever you send an e-mail to more than one person, do NOTuse the To: or Cc: fields for adding e-mail addresses. Always use the BCC: (blind carbon copy) field for listing the e-mail addresses. This is the way the people

you send to will only see their own e-mail address. If you don't see your BCC: option click on where it says To: and your address list will appear. Highlight the address and choose BCC: and that's it, it's that easy. When you send to BCC: your message will automatically say 'Undisclosed Recipients' in the 'TO:' field of the people who receive it.

- (3) Remove any 'FW:' in the subject line. You can re-name the subject if you wish or even fix spelling.
- (4) ALWAYS hit your Forward button from the actual e-mail you are reading. Ever get those e-mails that you have to open 10 pages to read the one page with the

information on it? By forwarding from the actual page you wish someone to view, you stop them from having to open many e-mails just to see what you sent.

- (5) Have you ever gotten an email that is a petition? It states a position and asks you to add your name and address and to forward it to 10 or 15 people or your entire address book. The email can be forwarded on and on and can collect thousands of names and email addresses. A FACT: The completed petition is actually worth a couple of bucks to a professional spammer because of the wealth of valid names and email addresses contained therein. If you want to support the petition, send it as your own personal letter to the intended recipient. Your position may carry more weight as a personal letter than a laundry list of names and email address on a petition. (Actually, if you think about it, who's supposed to send the petition in to whatever cause it supports? And don't believe the ones that say that the email is being traced, it just isn't so!)
- (6) One of the main ones I hate is the ones that say that something like, 'Send this email to 10 people and you'll see something great run across your screen.' Or, sometimes they'll just tease you by saying something really cute will happen IT AIN'TGONNAHAPPEN!!!!! (Trust me; I'm still seeing some of the same ones that I waited on 10 years ago!) I don't let the bad luck ones scare me either, they get trashed.

(Could that be why I haven't won the lottery?)

(7) Before you forward an Amber Alert, or a Virus Alert, or some of the other ones floating around nowadays, check them out before you forward them. Most of them are junk mail

that's been circling the net for Years! Just about everything you receive in an email that is in question can be checked out at Snopes. Just go to <a href="http://www.snopes.com/">http://www.snopes.com/</a> It's really easy to find out if it's real or not. If it's not, please don't pass it on.

So please, in the future, let's stop or at least minimize the junk mail and the viruses by taking the steps outlined above.
