# Adobe Photoshop Elements 10 & Premiere Elements 10



Not a lot has changed since our last look at the Photoshop Elements Family, version 8, in December 2009 and most of what we covered there is still accurate. What I will be covering here is what has been added since 2009 in versions 9 and 10. The four major additions to Photoshop Elements since Version 8 are:

1. Layer Mask Creation - You no longer have to create them manually.

2. Content-Aware Healing Brush - Now you can really make objects disappear, fix old photos, and fix defects by filling with background that is created from the surrounding area. This one feature alone is worth the price of Elements 10.

- 3. New in version 10, overlay guides have been added to aid you in cropping your photos using the Rule of Thirds and the Golden Ration. These guides allow you to crop your photos in such a way that the viewer is drawn away from the center of the photo by offsetting the primary focus of the photo against the background. These guides are a welcome addition to Photoshop Elements.
- 4. Also in version 10 are new guided tasks which include the Michael Orton effect, better Depth of Field adjustments using smart selection tools, and several other improved task oriented adjustments.



I will cover these improvements in some detail as they are definitely valuable additions to the Photoshop Elements family and are reason to consider upgrading to Version 10 from an earlier version if you are already a Photoshop User. I will also comment on the improvements to the Organizer and Adobe Elements Premiere.

#### The Two Photoshops

Photoshop CS and Photoshop Elements. Photoshop CS is Adobe's Premiere Professional Photo Editing program and it comes at no small price. Photoshop Elements is sometimes referred to as its little brother as it inherits features and tools from its elder brother. CS is a powerful photo editor and with power comes complexity. Elements is for the photo enthusi-

# Cerny's Cyber Sense

## What's The Difference Between "Save" and "Save As..."?

My usual answer to this question is "always use Save as...". Well, OK, now why? First, let me take a moment of your time to show the "save a file" process. If you open a program and create something NEW, when you are done

you probably want to save your work. If you click on the "Save" option, guess what? – you will get the "Save as..." Dialog Box. The "Save as..." Dialog Box is important because that is where you can see and change (if you wish to) the following three options:

- WHERE you save your file in what folder or disk.
- The **NAME of the file**. If it is the first time you are saving the file, you need to give it a good name that means something to you so you can find it again.
- The **FILE TYPE**. Many programs allow you to save a file with a selected file type. I don't want to get into file types here, but that is a great topic for another article.

Ok, so now you save your file with a good file name, right? So the next day comes and you

want to OPEN that file you created yesterday and make some changes to it. Once you have made some changes and you want to save the changed file – be careful now – do you click on "Save" or "Save as..."? If you click on "Save" you do NOT get the "Save as..." Dialog Box and BOOM your changed file has TOTALLY RE-PLACED your previous file with the same name. Thus, your previous file is GONE, and it is NOT in the recycle bin either. But if you always use "Save as...", you will always get the "Save as..." Dialog Box so you can check those three important file options (location/folder, name, and file type). If you choose not to change any of these options, then it is no different than using the "Save" option. But with "Save as..." you always get to see what is going on and you get a chance to change an option if you wish. If you do change the NAME of the file, then you will have two files saved, your old file before your changes and the new file with your changes and the new file name. So if you are in the habit of always using the "Save as..." option whenever you save a file (old or new) you will always be given the chance to change something if you want.

Choosing just "Save" will not give you those options unless your file is being saved for the first time.

ast, a consumer level product, where the focus is on ease of use. Elements 10 benefits greatly from its Photoshop CS heritage.

#### **Quick Edit Workspace**

The graphic shows the Quick Edit workspace. As you can see, there are sliders for each of the adjustments you can make here along with the "Auto" smart buttons where Elements 10 will make its best guess at the adjustment. If you don't like the Auto adjustment, you can undo the adjustment as well as reset all adjustments made here. On the left hand side of the screen are tools for cropping, red eye, teeth whitener, blue sky tool, and the Black & White High Contrast tool for turning a selected area into a high contrast black & white element. The High Contrast tool works by automatically creating a layer mask on the photo and a function from Adobe Photoshop CS to create the effect. Quick Edit provides an easy to use starting point for fixing your photos.

iCloud from Apple is waiting for all those using 3GS or later iPhones with iOS-5, along with the 3rd generation or later iPod Touch and all iPads, and don't leave out Macs running OS X Lion. To sign up and use iCloud, go to https:// www.iCloud.com; there will be a place to sign in using your Apple ID. Once iCloud is entered, there's information regarding what items you can sync. Now you will be able to move data wirelessly from one device to another or to your Mac or just store your data in the Cloud, using 5GB of free space. There's a fee for additional amounts of storage space.

Anywhere there's wi-fi available, you will be able to store and back up your devices or move data to your Mac by way of iCloud. Data that can be moved and stored are photos, contacts, calendars, videos and more.

Moving documents is one of the hot file management method people are using these days, and can be done in iCloud with files created in iWorks, Numbers and Pages. You can send documents to iCloud from any device and they will appear on your computer and any other compatible device (Continued on page 6)

you use. You can make changes to any document you have sent to iCloud, and those changes will automatically appear on all your devices/Mac.

There are several other useful features on the iCloud, such as Photo Stream, which is one way to move photos into iCloud, and from there to your Mac and other devices.

Photo Stream holds up to 1,000 photos and doesn't use data or any of your free 5 GB of space.

When you misplace or lose your Mac, iPhone, iPad or iPod Touch, you can use iCloud to find it.

With iCloud, you can lock the device, make it ring or just wipe the data clean. This process can be done from any computer anywhere by typing in iCloud.com, then using your e-mail and password to activate this function.

When syncing your Contacts to iCloud for the first time, some people are having trouble with double or triple contacts showing up on their devices. To solve this problem, go to your Mac Address Book and look for duplicates. In the Tool Bar, click on Card and then Look For Duplicates, then click Merge. Now the duplicates are gone.
